U.S. Senators Mikulski and Collins Honored for Increasing Federal Funding for Nursing Programs

U.S. Senators Barbara Mikulski (D-MD) and Susan Collins (R-ME) recently were honored with the first-ever Americans for Nursing Shortage Relief (ANSR) Public Service Award for their successful efforts to increase funding for nursing programs necessary to reverse the nursing shortage. The senators received the awards at a reception on Capitol Hill on March 1.

The ANSR Alliance is composed of 50 nursing organizations, including ONS, that collectively represent nearly all of the nation's 2.3 million nurses. ANSR's goal is to work with Congress to implement a comprehensive set of initiatives to increase the nursing workforce.

Recently, President Bush requested \$150 million for Nursing Workforce Development Programs in fiscal year (FY) 2006, representing a \$674,000 decrease from FY 2005. The President also proposed cutting \$15 million for advanced nursing education. Senators Mikulski and Collins have been the driving force behind significant increases in the Title VIII Nursing Workforce Development Programs. Funding for Title VIII increased from \$93 million in FY 2003 to \$151 million in FY 2005, thanks to their efforts. These programs provide funds for nursing education and other programs crucial to stemming the nursing shortage.

Senators Mikulski and Collins were recognized as true champions for nursing and for safeguarding the public health. They helped to increase funding for nursing workforce development programs over the last three funding cycles and were instrumental in steering the Nurse Reinvestment Act through the Senate in 2002.

New Cancer Clinical Trials Education Network Partners With Lance Armstrong Foundation

The Lance Armstrong Foundation (LAF) recently launched the Education Network to Advance Cancer Clinical Trials (ENACCT). This pilot education program is the only national organization devoted solely to implementing and evaluating cancer clinical trial educational efforts. ENACCT's mission is to identify and implement innovative approaches to cancer clinical trials education, outreach, and recruitment to improve outcomes for patients with cancer.

ENACCT seeks to address the issue of community literacy around clinical trials—changing knowledge, attitudes, beliefs, and intention in both healthcare providers and community leaders—to ultimately enhance access and increase participation in clinical trials.

Through a national competitive award process, the ENACCT pilot education project will award three grants to existing, effective community-based partnerships at \$150,000 per year for three years to develop unique approaches to fostering awareness about cancer clinical trials, enhancing their acceptability, and improving access to them. ENACCT will offer ongoing technical assistance, evaluation, and training services provided by the ENACCT pilot program staff and consultants. The action-oriented programs implemented and the lessons learned from them will help inform and improve patient recruitment-planning and activities nationwide.

The inaugural conference of the American Arab Nurses Association (AANA) was held May 19 at Burton Manor in Livonia, MI. "Building Cultural Bridges in Health Care" explored the value of cultural competency in clinical practice, the variances in cross-cultural communication, healthcare workplace cultural diversity, and healthcare beliefs and practices in Arab, African, and Hispanic American cultures.

Madeleine Leininger, PhD, LHD, DS, RN, CTN, FRCNA, FAAN, LL, the pioneer of transcultural nursing theory and practice and the founder of the Transcultural Nursing Society, was the keynote speaker. A panel discussion probed "Problem Solving Relating to Workplace Cultural Diversity," with representatives from the medical and corporate worlds. National Cancer Institute Forms Cancer Biomedical Informatics Grid

The National Cancer Institute (NCI) has formed a cancer Biomedical Informatics Grid (caBIGTM), a virtual network intended to link individuals and institutions around the world in hopes of accelerating cancer research.

Forty-nine NCI-designated cancer centers have signed contracts with NCI to build the grid, which will allow individuals and institutions to share data and tools, creating a World Wide Web of cancer research. The goal is to speed the delivery of innovative approaches for the prevention and treatment of cancer.

The caBIG pilot is being coordinated through NCI's Center for Bioinformatics to support its vision of providing a cancer research infrastructure via a virtual web of interconnected organizations and individuals to leverage the combined strengths of cancer centers and investigators and enable the redefinition of

- The methodology of cancer research
- The delivery of patient care
- The interaction and relationship of patients and participants with the biomedical research enterprise.

"caBIG will be a critical asset in meeting NCI's challenge goal of eliminating suffering and death due to cancer by the year 2015," said NCI Director Andrew C. von Eschenbach, MD.
